Welcome to **V1cryptopunks.com** (the “Marketplace”), a decentralized, community-operated platform for exploring, buying, and selling CryptoPunks NFTs.

By accessing or using the Marketplace, you agree to these Terms of Service (“Terms”). If you do not agree with these Terms, do not use the Marketplace.

1. Nature of the Marketplace

V1cryptopunks.com is a permissionless, non-custodial interface that connects users directly with smart contracts on the Ethereum blockchain. It enables peer-to-peer transactions and does not act as a broker, intermediary, custodian, or financial service provider. No centralized entity controls the Marketplace.

2. No Affiliation with CryptoPunks or NODE

V1cryptopunks.com is not affiliated with, endorsed by, or officially connected with The NODE Foundation (“NODE”), Larva Labs, or any entity that owns or manages the CryptoPunks intellectual property.

All images, branding, names, and IP associated with CryptoPunks are the property of their respective rights holders. Users are responsible for complying with any relevant licensing or IP usage terms provided by NODE or other IP owners.

3. NFT Ownership and Use

3.1 Ownership:

When you acquire a CryptoPunk NFT, you own the token on the blockchain, not the associated artwork or intellectual property, unless otherwise licensed to you by the IP holder (e.g., NODE).

You must comply with any license or usage terms published by the IP owner. V1cryptopunks.com does not grant you any rights to use or commercialize the artwork, names, or likenesses of CryptoPunks.

4.1 Wallet Connection:

Use of the Marketplace requires connecting a third-party Ethereum wallet (e.g., MetaMask, WalletConnect). You are solely responsible for the security of your wallet, private keys, and assets.

4.2 Smart Contract Transactions:

All transactions occur directly between users via public Ethereum smart contracts. These transactions are immutable and irreversible once confirmed by the blockchain.

The Marketplace may include optional interface fees, which will be disclosed prior to transaction execution. Gas fees are determined by the Ethereum network and are not controlled by V1cryptopunks.com.
